II. PRELIMINARY MATTERS

A. Opening Remarks and Announcements

Ms. Harris announced the following:

- A recent community outreach event was held in coordination with Friends of State Street. Participating groups included the local business, nonprofit, real estate, bike, alternative mobility, and performing arts communities. Staff held other outreach events as well.
- B. State Street Interim Operations Update

- 1. Sarah Clark, Downtown Plaza and Parking Manager, provided an update on interim activities along State Street. She noted that the major project underway is licensing all temporary outdoor facilities in State Street's right-of-way, and verifying that businesses are meeting stormwater and design requirements through the licensing process. She explained that once licenses have been issued, fees will be collected from businesses operating in the right-of-way.
- 2. Ms. Clark announced that staff from the Police Department, Traffic Engineering, and the City Attorney's Office have been developing a set of new bicycle regulations and code of conduct for cycling on State Street.
- 3. A pilot program called Little Living Rooms will provide chairs and seating on State Street for members of the public to rest and gather in the coming months. Results from this program will inform work on the master plan. Other near-future State Street activation events include Tiny Libraries and community game nights.
- 4. Ms. Clark noted that staff is considering design options for experimental division of bicycles and pedestrians.
